Transmitted herewith are 14 copies of a letter-head memorandum dated and captioned as above.

Five copies are for an individual file on instant individual, MANUEL AGUSTIN TUNON VALDES BRITO, and 9 copies are for captioned file on Cuban Intelligence Matters. ~~(S)~~(U)

One copy is furnished to Atlanta for information since TUNON has a half-sister, JULIA DE CARDENAS DE PAUSA, residing in Atlanta, whose husband is an M.D. at Georgia Baptist Hospital, Atlanta.

Military Intelligence Officer JOHN KOUN advised on January 18, 1963 that no deception had been detected in the examination of TUNON by polygraph. In view of this, and in view of the fact no deception was detected during the interview and he readily revealed as much information as he appeared to have regarding the identity of relatives still in Cuba, the case on TUNON is being placed in a closed status with this memo; since his induction into the U.S. armed forces appears to be imminent no consideration is being given to utilizing him as a possible source of information.

Cuba were unloaded. This CABRERA has a younger brother, whose first name is also unknown to TUNON, but who is also a Communist. While at the airport, CABRERA had a secretary, first name INEZ, last name unknown. She was the fiancée of the son of the CABRERA who was transferred to Mariel.

TUNON stated that a Lieutenant ORLANDO MATOS, known as "El Matador," was the head of G-2 at the air-~~port~~ [CS] when TUNON was last employed there. He is about 30 years of age and is now with the part of [G-2] which patrols the streets in Havana. 1933

Personnel of Compania Cubana de Aviacion (Cuban Aviation Company) (CCA), who are either [G-2] or [CS] who report to Cuban G-2 are Stewardesses KATIA CARABALLO and her first cousin, DAISY DUENAS CARABALLO. TUNON stated that KATIA CARABALLO formerly flew for "Q" Airlines from Havana to Key West, and then started flying with CCA at about the time flights were begun by CCA to Iron Curtain countries. He stated her mother is a cousin to his mother and therefore his second cousin. FLA CUBA

The son of the Cuban guerrilla warfare trainer, General ALBERTO BAYO, is a co-pilot for CCA and is completely aligned with the CASTRO regime, believed by many to occupy a position of trust, and having relationship between some intelligence leaders of Cuban G-2, [CS] and contacts in other countries.
