communication (letterhead memo) was made available locally  
to CIA.

Upon receipt of original info re the activities  
of captioned subject on 4/13/62, Mr. RAY DUBOIS, CIA  
local representative, was contacted and apprised of the  
contemplated travel of CUESTA and his companions to Cuba.  
At this time DUBOIS stated that CIA was aware of the activities  
of CUESTA and advised that CUESTA would probably not be  
traveling to Cuba at that time. (u)

Mr. DUBOIS was recontacted on 5/8/62 re the more  
specific data pertaining to CUESTA and ROBERTO HERRERA. At  
this time DUBOIS stated CIA has an operational interest in  
CUESTA and HERRERA and that CIA was aware of their travel  
arrangements to Cuba. (u)
