There is being forwarded herewith a list of suspected Cuban agents compiled as of November 1, 1960. This list was made available to the San Diego Office by Investigator BEN PEARSON of United States Immigration and Naturalization Service (USINS) - San Ysidro, California on February 10, 1961.

Mr. PEARSON advised that the list had been forwarded to him by the District Office of USINS at Los Angeles but that he did not know which office of USINS had compiled it. Mr. PEARSON made a copy of his list and furnished it to the San Diego Office. It is noted that some of the names are blurred and difficult to read.

It is not known whether or not the Bureau has been furnished a copy of this list by the Central Office of USINS. It is also noted that the residence of those suspects listed is mostly in the Miami area and the Bureau may wish to make that information available to the Miami Office.
