JOHN ROSELLI, AKA JOHN ROSSELLI

On August 17, 1955, Lt. M. B. PHILLIPS, Intelligence Division, Los Angeles Police Department, advised that ROSELLI, using the alias of <u>RAND FIELD</u> in booking transportation on planes out of Los Angeles, California, has been a frequent visitor to Las Vegas, Nevada, and made one flight to New York City, New York, in January of 1955. PHILLIPS stated that ROSELLI also made trips by plane from Los Angeles to Palm Springs, California.

Lt. PHILLIPS remarked that ROSELLI is very close to the owners of the television show "Medic" and police believe he may actually be one of the owners. PHILLIPS stated they have attempted to obtain full details concerning the ownership of this show and have been unsuccessful. PHILLIPS reported that ROSELLI remains close to motion picture producer BRYAN FOY and to TOMMY GUINAN, brother of the late night club entertainer, TEXAS GUINAN. Another associate of ROSELLI's is GEORGE BURROWS, reported to be one of the authors of the show "Guys and Dolls".

PHILLIPS reported that in 1954 ROSELLI reportedly flew to New York City from Los Angeles for the purpose of seeing GEORGE SCALISE, recalled as being connected with the motion picture union racket of a purpose of years ago.

Lt. PHILLIPS advised on October 6, 1955, that police have learned that ROSELLI possibly has the concession for the sale of playing cards to the gambling clubs in Las Vegas, Nevada.

LA 3445-C advised SA JOHN E. KELLY on October 24, 1955, that he is acquainted with ROSELLI, and the informant's wife has been in ROSELLI's apartment at 1251 North Crescent Heights Boulevard, Los Angeles. Informant stated his wife described this apartment as having been furnished in a luxurious fashion. Informant pointed out that this apartment house is owned by CAL/FATON, notorious Los Angeles boxing promoter whose son is married to a daughter of Governor GOODWIN J. KNIGHT. Informant said ROSELLI is on friendly terms with some of the residents in the apartment house, including EATON's son who formerly resided there. It should be noted that LA 3445-C formerly resided in the same apartment house.

ROSELLI has a non-published telephone number HOllywood 7-1711. A review of the toll calls on ROSELLI's phone reflects that he made and received calls from a Miss CONNORS in Las Vegas and from BELDON MATTLEMAN in Las Vegas.
