Enclosed herewith for the Bureau are six copies of a letterhead memorandum, which is self-explanatory, for transmittal to the Legat, Rome, Italy.

The source of information referred to in the enclosed letterhead memorandum is NY 3803-C, who furnished this information on 4/18/63.

The informant advised that he received this information from ANGELO CHIEPPI, Newark top hoodlum, who also advised that SAM GIANCANA, Chicago top hoodlum, would see GIUSEPPE ANTONIO DOTO on the New Jersey shore. Informant stated that CHIEPPI also indicated that other persons, identities not furnished, would see DOTO.

Chicago requested to be alert for any travel plans on GIANCANA's part during June or July, and Newark requested to be alert for any information relative to DOTO's proposed visit.

Chicago, Newark and New York will conduct no inquiries relative to this proposed visit at the present time.
