NK T-3 is NK 2327-C, who is an individual who has had a long association with criminals and their activities and was once considered for membership in Causa Nostra.

NK T-4 is NY 3803-C, who has been engaged in criminal activities for many years and has been confined in various penitentiaries in the U.S.

NK T-5 is NK 2319-C\*, and is in a position to furnish accurate information concerning Causa Nostra in New Jersey and neighboring states.

NK T-6 is PH 591-C\*, who is in a position to furnish information pertaining to Causa Nostra in the Philadelphia area.

NK T-7 is PH 623-C\*, who is in a position to furnish reliable information concerning Causa Nostra, particularly regarding the ANGELO BRUNO Family.

NK T-8 is SF 2550-C-TE, who is associated with persons having knowledge of Causa Nostra activities in the New York area.

NK T-9 is NY 3368-C-TE, who has knowledge of certain members of Causa Nostra.
