- T-24 An individual who possesses a criminal record, has a wide acquaintance with underworld figures in the New York City area, and remains in close contact with many underworld figures.
- T-25 A representative of a state agency which conducts criminal type investigations.
- T-26 A native of Brooklyn, N. Y., who possesses a criminal record and is acquainted with many underworld figures.
