Referenced letter requested this office to have sources recontacted to determine if subject held any other insurance policies besides that resulting in the \$185,000 claim which was paid in April 1949. \$70,000 of this was held by Lloyds of London as reinsurers for the American International Reinsurance Corporation of New York City. Referenced letter also requested that it be determined if JOSEPH STASSI was recipient of any payment. (S)

Reference is made to mylet April 27, 1961, which it is believed answers this question and also to mycable, June 20, 1961, which stated no other information is available regarding this matter [and that Lloyds of London do not require details regarding the individual policy holders, but merely reinsure other insurance companies against undue or large losses] (S)

This matter was again discussed with British Security Service MI-5 and [redacted] advised that the name JOSEPH STASSI is unknown to his source; that subject is only indirectly known to his source; and that any further information available could only come from the original insurers who are the New York City reinsurance organization, as mentioned above. [redacted] stated his sources are unable to determine if subject or STASSI or both received the \$185,000 insurance payment and as far as Lloyds of London are concerned, their only record of payment was \$70,000 to American International Reinsurance Corporation of New York City.
