Referenced letter requested this office to have sources recontacted to determine if subject held any other insurance policies besides that resulting in the \$185,000 claim which was paid in April 1949. \$70,000 of this was held by Lloyds of London as reinsurers for the American International Reinsurance Corporation of New York City. Referenced letter also requested that it be determined if JOSEPH STASSI was recipient of any payment.
