This information was voluntarily furnished by [redacted] a PCI of this office, to SA JOHN B. O'LEARY.

[redacted] had been reading an article in the Albuquerque Journal of 8/22/58, concerning the appearance of BARNEY BAKER before the Senate Rackets Investigating Committee and stated, as he had been a member of the Teamsters' Union, Detroit, he would like to make available some information concerning the Teamsters' Union activities.

[redacted] is aware of the fact that the FBI does not investigate labor activities as such, but realizes his information was voluntarily made available. He thought perhaps the Bureau might be interested in receiving such information and might desire to make it available to the Senate Committee investigating illegal activities in the various Unions.

The enclosed is being furnished for the Bureau's information.

This PCI is not available for testifying before a Committee or Hearing Board.
