REFERENCED BUREAU TELETYPE REPORTED THAT LEGAT BUENOS AIRES RECEIVED INFORMATION FROM CHILEAN GOVERNMENT THAT A MEMORANDUM DATED DECEMBER 4, 1974, NUMBER R-287, REPORTED THAT LUCAS BORGES, PRESIDENT OF A CUBAN CLUB IN ELIZABETH, NJ, HAD REQUESTED THE CHILEAN GOVERNMENT TO ALLOW ORLANDO BOSCH AVILA TO COME TO CHILE AND TAKE UP RESIDENCE THERE.

FILES OF THE NEWARK OFFICE REFLECT THAT LUCAS BORGES IS IDENTICAL WITH LUCAS M. BORGES Y DE CARDENAS, BUFILE 105-90114, NEWARK FILE 97-273. THIS FILE REFLECTS THAT LUCAS M. BORGES Y DE CARDENAS WAS BORN ON NOVEMBER 8, 1921, IN BAYAMO, ORIENTE, CUBA.

WHEN DR. BOSCH VISITED THE NEW JERSEY AREA ON A FUND RAISING VISIT. BORGES STATED THAT HE NEVER WAS PERSONALLY CLOSE TO DR. BOSCH, HAD NEVER BEEN REQUESTED BY ANYONE TO CONTACT THE CHILEAN GOVERNMENT AND REQUEST PERMISSION FOR BOSCH TO RESIDE IN CHILE. (u)

BORGES ADVISED THAT IF THE INFORMATION IS TRUE THAT A LETTER WAS SENT ALLEGEDLY BY HIM TO THE GOVERNMENT OF CHILE REQUESTING PERMISSION FOR DR. BOSCH TO LIVE IN CHILE, IT IS POSSIBLE THAT SOMEONE ELSE HAD MADE THE REQUEST AND HAD SENT THE LETTER OUT UNDER HIS, BORGES', SIGNATURE. BORGES STATED THAT WHEN HE FIRST OPPOSED THE CASTRO GOVERNMENT, HE WAS ACTIVE IN THE ~~MOVIMIENTO REVOLUCIONARIO DEL PUEBLO (MRP)~~, HEADED BY ~~MANUEL RAY~~ AND ~~NINO DIAZ~~. BORGES STATED THAT CURRENTLY HE IS AN OFFICER IN A ~~CUBAN ORGANIZATION CALLED CABALLEROS DE LA LUZ~~ WHICH IS LOCATED IN NEWARK, NJ. BORGES STATED THAT THIS ORGANIZATION IS APOLITICAL AND IN NO WAY IS INVOLVED IN REVOLUTIONARY OR TERRORIST ACTIVITY. (u)

NKT 1 ON SEPTEMBER 27, 1977, ADVISED THAT HE KNEW LUCAS BORGES VERY WELL, AND IN FACT, WAS HIS SPONSOR INTO THE UNITED STATES. (u)

STATES WHEN BORGES FIRST ENTERED THE UNITED STATES IN THE LATE 1950'S. NKT1 STATED THAT BORGES IS NOT A POLITICAL FIGURE AND DOES NOT HAVE ANY HIGH-RANKING CONTACTS IN OTHER GOVERNMENTS, AND ESPECIALLY WITH THE GOVERNMENT OF CHILE. NKT1 STATED THAT BORGES IS A SIMPLE AND SINCERE INDIVIDUAL AND THAT HE PERSONALLY KNOWS THAT BORGES IN NO WAY IS CONNECTED WITH DR. ORLANDO BOSCH AVILA. ~~(S)~~ (U)
