ABOVE FURNISHED TO CUSTOMS, MIAMI, WHO STATED THEY WERE INTERESTED IN INVESTIGATING MATTER AND PARTICULARLY INTERESTED IN BARTONE-S CONNECTION WITH THIS CASE.

TODAY [REDACTED] ADVISED BALBUENA HAD SPOKEN TO BARTONE WHO SAID HE DOES NOT WANT TO DO BUSINESS IN MIAMI BECAUSE HE IS AFRAID OF FEDERAL AUTHORITIES. HE MADE ARRANGEMENTS FOR BALBUENA AND HIS BODYGUARD OF JUNE TWENTYFIVE TO FLY TO NEW YORK AROUND MIDNIGHT TONIGHT.

OTHER 4

BODY GUARD AND BALBUENA WILL OBTAIN EQUIPMENT IN NEW YORK AND BARTONE-S PEOPLE WILL SEND EQUIPMENT FROM NEW YORK TO SOME ISLAND IN CARIBBEAN WHERE DUQUE AND HIS GROUP WILL PICK UP THE EQUIPMENT.

BALBUENA WILL RETURN MIAMI IN THREE OR FOUR DAYS AND WILL GIVE FURTHER DETAILS TO INFORMANT.

BARTONE-S BODYGUARD DESCRIBED AS W.M., AGE THIRTY, SIX FEET TALL, ONE SIXTY POUNDS, BLACK WAVY HAIR, THIN BUILD, SPORTS CLOTHES.

BALBUENA DESCRIBED AS W. M., AGE THIRTYFIVE, SIX FEET TALL, TWO FORTY POUNDS, HEAVY BUILD, BROWN HAIR AND EYES, LARGE STOMACH.
