In October 1965 our Prince George Detachment in British Columbia received information from a confidential source that the three captionally noted persons met in the interior of British Columbia during September 23 to 25, 1965, using a hunting trip as a "cover".

According to information received, the two CAPOLINO brothers arrived in Prince George, B.C. in the p.m. of September 16, 1965, via Canadian Pacific Airlines from Edmonton. They stayed in the Prince George Hotel during the night of September 16th and on either September 17th or 18th were flown by private plane (Northern Mountain Airlines Limited, Prince George, B.C.) to a hunting lodge on Warwa Lake in the interior of B.C. From Warwa Lake the CAPOLINOs then proceeded to Belcourt Lake, B.C., on September 23, 1965. When the CAPOLINOs and party arrived at Belcourt Lake, they were met by another aircraft which contained another hunter and a big game guide named John CALLIOU of Kelly Lake, Cona la Investigation has indicated that the hunter waiting at Belcourt Lake may have been Samuel (Sam) MANNARINO of New Kensington, Pa. When the CAPOLINOs arrived, they were warmly greeted by the hunter believed to be MANNARINO. These three persons then proceeded to remain in close company for one and a half days and were observed to engage in secret conversations, separate from other persons in the hunting party. The feeling was that the

CAPOLINOs and MANNARINO had pre-arranged this meeting. The CAPOLINO brothers and MANNARINO departed company on the morning of September 25th when they continued on their separate ways to hunt big game.

- Investigation in B.O., revealed that Sam MANNARINO of New Kensington, Pa., Albert HANNA of New Kensington, Pa., and Dr. D.H. SCHUMAHER of Road #2, Leidberg, B.C., were hunting in the interior of B.C. during the period in question and were guided by Johnny CALLIOU. Furthermore, the CAPOLINOs were overheard to mention that the man they met at Belcourt Lake was caught in the Apalachin Mountains during a Mafia meeting. This, therefore, led our investigators to believe that the hunter met by the CAPOLINOs was Samuel MANNARINO.
- Our records indicate that Samuel MANNARINO is subject of your FBI #115840, born 1-Jan-06, Pittsburgh, Pa. MANNARINO's last known address was 201 Highland Avenue, New Kensington, Pa., and his brother Gabriel MANNARINO, born 31-Oct-16, New Kensington, Pa., was an Apalachin delegate. Gabriel MANNARINO is subject of your FBI #854-850, our FPS #889382. Samuel MANNARINO, you will recall, was arrested by your Department in connection with the Brockville Bank and Trust Company robbery in 1959-60.
- 5. The following particulars were obtained on the CAPOLINO brothers: -
 - 1) Ilando CAPOLINO born about 1923.
 Address 2265-82nd Street, Brooklyn, N.Y. 11214.
 Description: 250 lbs., stocky build, black hair,
 dark complexion.
 - 2) Guido CAPOLINO born about 1930. Address - 1143-78th Street, Brooklyn, N.Y. 11228. Description: 185 lbs., black hair, dark complexion.

The CAPOLINO brothers claim to be principals in Capolina Sons Incorporated, Lathing and Plastering Contractors, 8005-3rd Avenue, Brooklyn 9, New York, phone no. BE8-3474.

6. Investigation on the CAPOLINO brothers revealed that they previously hunted in the interior of British Columbia in 1964. It was also learned that in 1964 they were in search of property in B.C. in order that they might escape the influence of the Mafia in the United States.

7. During the present hunting trip in the interior of British Columbia, the CAPOLINOs became very provocative to their guide and refused at first to pay him. When the guide threatened the CAPOLINOs that he would go to the police, they subsequently paid him with a cheque for \$2,200.00 drawn on a Canadian bank in Toronto. Enquiries are presently underway to obtain further particulars on the cheque issued by the CAPOLINOs. The CAPOLINOs left the interior of B.C. on or about October 7, 1965.
