Enclosed for your information and attention is one copy of a letter from the Legal Attache, Paris, dated 10-15-59, together with a letterhead memorandum of the same date. Also enclosed are 97 photographs of material obtained by the Direction de la Surveillance du Territoire (DST). (S)

The so-called personal code mentioned in Legal Attache, Paris, letter apparently pertains to frequency tables used in linotyping. It is desired that you review the material obtained (through the cooperation of DST) for any information of value and, if necessary, furnish pertinent information to interested offices for inclusion in the respective files of the various individuals named.

The Bureau should be advised of the results of your analysis in this matter.

Subjects, husband and wife, are key figures of the San Francisco Office. John Pittman obtained a visa in Paris from Russian consulate for entrance into Russia to act as Moscow correspondent for the "Daily Worker." Subject's expenses to Russia paid by the Soviets. This information is known only to NY 694-S\* and CG 5824-S\* and has not been disseminated outside the Bureau.
