ReLonlet 4/20/64 advising that PERRY's file remained pending to be followed with British Security Service, MI-5.

On 7/29/64 the PERRY matter was discussed with RALPH WHITBY, MI-5 Case Officer handling it. He advised that to date MI-5 has no pertinent additional information concerning PERRY's activities. He said that because of certain political considerations MI-5 cannot interview PERRY and he explained the considerations as being British-Red China trade relationships. (5)

WHITBY said MI-5 continues to afford coverage to the Chinese Diplomatic Mission in the United Kingdom, certain coverage to PERRY, and any information coming to their attention which they consider to be pertinent to Bureau responsibilities and individuals in whom the Bureau is interested will be furnished to this office.

In view of the foregoing, this matter is considered RUC.
