On 10/25/62 with enclosure captioned "Reorganization Revolutionary (ARR)" which contains information concerning captured group.

Enclosed for each office is copy of Army report dated 9/24/62. No record of captured organization was located in files.

With reference to statement in paragraph two, page one, of attached report, that the information will not be passed to any agency outside Department of Defense or FBI, Army advised on 10/5/62 it had no objection to inclusion of the information in reports prepared for dissemination to State, Central Intelligence Agency, Immigration and Naturalization Service and other interested agencies.

San Juan immediately institute investigation to determine background of captured group, its strength, source of funds, identity of leaders, whether it has foreign principal and nature of its activities. Of particular interest would be any pertinent information that it has actually entered on its plan to infiltrate 36 armed guerrilla fighters into this. (S)(u)

(2-1) (u) mentioned in attached report should be further identified if possible. [redacted] appears identical with [redacted] former San Juan file. [redacted] appears identical with [redacted] presently RUC of San Juan Office.
