For information New York, NK 2251-C\* reported on discussion between DeCarlo, Si Rega, Carl Silesia and Sam DeCavalcante regarding death of Nick Delmore. Text of retel indicated that Delmore's death now makes DeCavalcante "boss," and mention is made that he had previously been "underboss" prior to Delmore's death.
