Reference is made to information reported by NY 3461-C-TE that a ceremony was held at an undisclosed location in the New York City area on 4/5/64, at which time a "boss" and "underboss" of the old PROFACI "family" were installed.

It is interesting to note that the leading figures of the MAGADDINO family were absent from the Buffalo area on 4/5/64. BU 264-C* reported that FRED G. RANDACCIO, the "underboss" of the STEVE MAGADDINO "family" left Buffalo for New York City on either 4/2 or 3/64. It is also noted that this trip was treated with utmost secrecy by RANDACCIO and upon his return he mentioned to his paramour, DARLENE GRANN, of seeing the World's Fair even though it was not open to the public at the time.

It is also noted that BU 280-C* reported that STEVE MAGADDINO and his son-in-law left Buffalo for New York City on 4/2 or 3/64, with later plans to travel from New York City to Florida. This source reported that MAGADDINO and MONTANA returned to Buffalo - Niagara Falls, New York area on the weekend of 5/2/64. Based upon information from BU 280-C*, MAGADDINO and MONTANA were staying at a hotel or motel at Fort Lauderdale, Florida, where MAGADDINO went swimming daily in the ocean or in the pool. He could see the lights of Miami or Miami Beach from this location. He mentioned going deep sea fishing and catching a large king fish. MAGADDINO described the scenery from the place he was staying as beautiful and Woold at Felative he had "lots of company."
