The revelations of JOSEPH VALACHI have received considerable prominence in recent editions of newspapers across Canada and on this date the Legat was contacted by Assistant Commissioner AL PARSONS, Director, Operations and Criminal Investigations, RCMP Headquarters. PARSONS had just been talking with Superintendent THIVIERGE, who is in charge of criminal investigations branch for the RCMP in Montreal, Quebec. THIVIERGE, in turn, advised PARSONS he had just had a discussion concerning the revelations of VALACHI with Chief ROBERT, Montreal City Police Department. According to ROBERT, sources of the Montreal Police Department indicate the Montreal underworld is "extremely restless" as a result of the publicity attendant to the VALACHI matter.

Assistant Commissioner PARSONS said to date no information has been received by the Force or by the Montreal PD which would indicate the revelations of VALACHI included identities of the Canadian underworld element. PARSONS requested the writer to be certain if at all possible that the RCMP be kept advised of any and all information of interest to Canadian authorities resulting from information obtained from VALACHI. This request is being brought to the attention of the Bureau and it would be greatly appreciated if it could be borne in mind and this office advised of any such information received which may be so disseminated.
