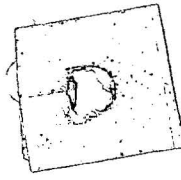

On May 20, 1965, CS RIO-2^(c) advised that captioned individual reportedly would be interviewed on TV that night. Source advised that this individual reportedly is a very outspoken anti-CASTRO person and that he probably would attack CASTRO on the TV program. Source was instructed by Legat to monitor the TV program.

On May 21, 1965, CS RIO-2^(c) advised that AGUERO had appeared on the TV program "INTERVIEW" at 11:30 P.M. the previous day on Channel 6 in Rio de Janeiro. Source advised that AGUERO made a "tremendous" attack on the regime of FIDEL CASTRO relating cases of shootings, killings and mass imprisonment of ex-comrades of CASTRO, after which CASTRO revealed his true tendencies in the government. Source advised that AGUERO stated that in Cuba there are no longer in existence political parties, including the Communist Party -- that there exists a government anti-human and against the people. Source advised that AGUERO finished by asking the Brazilian public and Brazilian Government to intervene in the political life of Cuba, as they were doing in connection with the Dominican Republic, in order to save the Cuban people from a great tragedy.

Source advised that he had determined that AGUERO is visiting several Latin American countries making similar appeals and that he is presently, reportedly, residing in Miami, Florida.

The foregoing is furnished as a matter of possible interest to the Bureau and the Miami and San Juan Offices.
