ADMINISTRATIVE

In San Diego reference letter to the Bureau, information is set forth that the Capo Regime of the San Diego Regina was believed to be one "ARNATO" (phonetic). The Capo Regime has now been identified as JOSEPH ADAMO, and information is set forth in this report that, because of a relationship between FRANK DESIMONE and the wife of GIROLOMO (MOMO) ADAMO, BROTHER OF JOSEPH ADAMO, GIROLOMO ADAMO became "Cornuto" or in disgrace, according to Sicilian standards. GIROLOMO ADAMO may have been the Capo Regime of the San Diego Regina at this time, and this may have been why source identified the San Diego leader as "ARNATO" (phonetic).
