CV-278-C-TE was recontacted on 6/4/64 and he advised that DOMINICK MALLAMO exhibited the photos of SAs STANLEY E. PETERSON and FRANK G. DOUDS to him so there would be no doubt that he would know them and be able to recognize them and to have nothing to do with them at any time. He stated that following his viewing of the photos, MALLAMO told him that he wanted him to work as a lookout at the C.M.A.S. Club, and he stated that it is his impression that that was the reason MALLAMO wanted the informant to know the Agents, so that he could readily recognize and identify them should they come to the Club that evening for any reason. Informant further stated that when MALLAMO showed him the photos, he took them from his wallet; however, he is not certain as to whether or not he carries them in his wallet at all times. Informant

was questioned as to the origin of the photos, and he advised that he asked MALLAMO where he obtained them, and MALLAMO told him they were copied from a newspaper photo. Informant stated, however, that he could not be sure that the photos were copies from a newspaper, in that they were clear and were not full length photos, and only were from the waist up.

Regarding the possibility of MALLAMO being questioned at any time by local authorities, and the possibility of locating these photos, this would seem rather doubtful at this time. In view of MALLAMO's association and influence with officers of the Youngstown PD, it is rather improbable that he will be picked up and questioned by local authorities. It is further to be noted that CV-278-C-TE stated he has heard that MALLAMO committed a murder in Youngstown in the late 1920's or early 1930's and never was prosecuted for same, except that he left Youngstown for a period of time. Further, MALLAMO was sentenced to a term in the Mahoning County Jail during the early 1940's following a State rackets investigation, and no record of same is maintained in the Identification Division of the Youngstown PD.

This office will remain alert, however, to MALLAMO's being questioned at any time by local authorities, and if the occasion arises, an attempt will be made to locate these photos.

Re: PROSECUTION IN LOCAL MAHONING COUNTY COURT OF COMMON PLEAS, YOUNGSTOWN

Regarding ANTHONY "BCOZE" GIANFRANCESCO, previously convicted for promotion of a numbers game and who did not appear as ordered by the court, it is to be noted that Mahoning County Prosecutor CLYDE W. OSBORNE advised that on 5/22/64 the U. S. Supreme Court ordered that GIANFRANCESCO be admitted to bail pending filing and disposition of a petition for writ of certiorari. The stay was conditioned upon his posting of a \$5,000 bail bond with the Seventh District Court of Appeals of Ohio.

Mahoning County Prosecutor OSBORNE advised that tentative arrangements have been made for DAVID COMAN, previously indicted by the Mahoning County GJ, to come into Common Pleas Court before Judge SIDNEY RIGELHAUPT with his
