On 6/11/64, NY 3461-C-TE attended a meeting of a portion of the COLOMBO "family", which was held at the home of JOSEPH GRECO, New Utrecht Avenue, Brooklyn, NY. Informant stated the purpose of the meeting was to introduce the "captains" in the COLOMBO "family" to the members of the regime of "boss" JOE COLOMBO, who is also in addition to his duties as "boss" acting as a "captain".

Informant pointed out that GRECO is not a member of "~~La Cosa Nostra~~" and yet the meeting was held in his apartment. He stated that neither GRECO nor any members of his family were present in the apartment while the meeting was held.

In view of the fact that a live informant was present at this meeting, the NYO will disseminate this information to only case files in the NYO, no dissemination will be made in any reports from the individual case files, and all files will contain a warning that under no circumstances is any of the information set forth below to be contained in any reports submitted by the NYO.
