On 6/21/67, NK 2376-C-TE advised that the leadership structure decided on for the BONANNO family a few weeks ago has again been changed. At the present time, there have been no new decisions made, but PAUL SCIACCA, New York City, has been placed in charge of the family on a temporary basis until a decision can be made.

According to the source, JOSEPH ZICARELLI, top NJ hoodlum, has been dropped as underboss and is without a position of leadership at the present time. The "New York boys", who were in the habit of visiting ZICARELLI on almost a daily basis, no longer visit him since he has lost his position.

The source stated that he had learned that SCIACCA will remain in charge of the family until a final decision is made. This decision will be made by representatives from five families and will be a binding one. The source reiterated that the problem lies in the fact that JOSEPH BONANNO is unwilling to step aside gracefully and still hopes to regain his old power and position.
