On April 28, 1967 SF 2550-C-TE was interviewed concerning his knowledge of the members of the Detroit Family of the LCN. Informant advised he was not personally acquainted with any of these individuals, nor could be furnish any information regarding them. He advised some of the hames sounded familiar to him and he assured that JOHN and PETH MISURACA had mentioned these names; however, he could recall nothing specific regarding them.

On 5/11/67 SF 2689-C-TE was interviewed concerning the Detroit Family of the LCN. He advised he has no specific knowledge concerning the group there, but stated he has heard that JOE KERILLI is the "Boss" in that area. He advised that this is just from what he had heard and he has no personal knowledge concerning the Detroit LCN.
