Re Omaha letter to Detroit 6/26/67, and DElet to the Director 4/14/67.

Re Omaha letter indicates that OM 148-C-TE has information concerning individuals associated with LCN in Detroit.

Enclosed herewith for the investigative assistance of the Omaha Office are 30 Xerox copies of cards containing brief background data and including, where available, photos of individuals all of whom are reportedly closely connected with LCN in Detroit. Also enclosed is a copy of DElet 4/14/67, which sets forth brief descriptive data concerning the Detroit LCN "family" and individuals associated with that "family."

The attention of the Omaha Office is also called to the LCN Index cards, 14 in number, which relate to principal figures of the LCN "family" in Detroit.

Omaha is requested to reinterview OM 148-C-TE for all information in his possession concerning the makeup of the Detroit "family", the identity of the leaders, and the identity of any other individuals associated with LCN in Detroit. The informant should be specifically requested to enlarge on his comments concerning JOE ZERILLI and ANGELO MELI.
