Reference is made to your memorandum of
24-Oct-66 concerning the apprehension of numerous individuals
while dining at the La Stella Restaurant, Queens, New York.

2. We are particularly interested in Joseph
N. GALLO. On 10-May-67 one Colagero Gino ~~LORE~~ (B. 9-Sept-30
Palermo, Sicily, subject of our FPS 238652A) was arrested in
Toronto, Ontario, for possession of counterfeit Canadian currency
and possession of an unregistered firearm. During his interro-
gation by Immigration Officials, LORE indicated that he had
resided in the United States for several years, particularly
New York City. He claimed to have an acquaintance with "CRAZY
JOE" believed to be Joseph GALLO, FBI # 120842A.

3. Joseph GALLO FBI # 120842A is recorded
in the charts and material prepared as a result of the McClellan
Committee Hearing, as being a member of the Giuseppe MAGLIOCCO
family of New York City. Joseph N. GALLO who is referred to
in your correspondence mentioned above bears FBI # 2444809,
however, a perusal of his arrest record fails to reveal that
he uses the alias "CRAZY JOE". May we be advised if Joseph
GALLO FBI # 120842A and Joseph N. GALLO FBI # 2444809 are in
fact are the same person or are perhaps related. Should they
not be the same individual, may we be supplied with a copy of
the fingerprints, photograph and criminal record of Joseph
GALLO alias "CRAZY JOE", FBI # 120842A.

**LA COSA NOSTRA
AR - CONSPIRACY**

Reference is made to your letter of July 6, 1967, requesting data on two New York City hoodlums named Joseph Gallo. In January of this year you were furnished the identification records, fingerprints and photograph of Joseph N. Gallo, FBI number 2444809, who is a member of the Carlo Gambino La Cosa Nostra "family." He is also the individual mentioned in your referenced letter as having been arrested September 22, 1966, at the La Stella Restaurant in Queens, New York.

Joseph Gregory (Crazy Joe) Gallo, on the other hand, is a member of the Joseph Colombo "family" and has FBI number 120842A. He is presently serving a 7½-14½ year term in the New York State Prison on a charge of conspiracy to commit extortion. A copy of his identification record, fingerprint card and photograph are being enclosed herewith as you requested.

There is no known relationship between the two Gallos.
