NK 2327-PC on 8/24/67 advised SA BERTIE J. WRISTON, JR., that representatives of the BLACK MUSLIMS and SNCC and two prominent Negro numbers bankers in Newark, N.J., are negotiating to join forces to take over the numbers business from the LCN in the Negro areas of Newark. The "mob" has already decided to kill the two Negro numbers operators and take whatever other necessary action if a takeover is attempted.

Informant estimated the total take from the numbers lottery in Newark each day is \$150,000.00. The Negro extremists could build a sizeable "war chest" if they can seize a third of the numbers business.

Informant is of the opinion the Negroes could not protect its numbers operation because the LCN would spend the necessary money to get individual Negroes to betray and
