ON JULY TWENTY SIX, LAST, BU FOUR ZERO NINE-C-TE ADVISED THAT A LOCAL BOOKMAKING OPERATION UNDER THE CONTROL OF FRED G. RANDACCIO, THE UNDERBOSS OF THE MAGADDINO FAMILY, WAS CURRENTLY BEING CONDUCTED AT BUFFALO TELEPHONE NO. EIGHT FIVE THREE - TWO SIX FOUR THREE. INFORMANT SAID THAT THIS NUMBER WAS BEING UTILIZED TO ACCEPT BOTH HORSE AND SPORTS BETTING ACTION. SUBSEQUENT INVESTIGATION DETERMINED MICHAEL A. GIGLIA WAS ACCEPTING WAGERS AT ABOVE TELEPHONE NUMBER, LOCATED AT TWO ZERO TWO WHITNEY AVENUE. INFORMATION DISSEMINATED TO CAPTAIN KENNETH P. KENNEDY, GAMBLING SQUAD, BUFFALO PD.
