On 4/26/66 Lieutenant EDWIN M. CUSTER, JR., Chief of Intelligence and Law Enforcement, U.S. Coast Guard, San Juan, advised his office was in receipt of information from Coast Guard, Miami, indicating that on 4/12/66 JORGE GUTURREZ ULLA (probably identical with JORGE GUTIERREZ), Chief of Information for MIRR, stated that organization is planning two operations. The first of these is the sabotage of a ship belonging to some nation which continues to trade with communist Cuba. This act of sabotage will take place either in Miami or Puerto Rico. GUTIERREZ indicated that JOSE RODRIGUEZ PEREZ, who was arrested in Miami in connection with the bombing of the Spanish motor vessel "Satrustegui" would not participate in this operation since the purpose of this sabotage is to distract from the fact that RODRIGUEZ PEREZ took part in the sabotaging of the "Satrustegui". (S-1)(u)

Miami requested to advise if that office is in receipt of information to this effect and advise San Juan accordingly.
