On 4-17-66, MM 639-S advised that on 4-16-66,
he accompanied ORLANDO BOSCH and GUAJIRO (JOSE ANTONIO
MULET GONZALEZ) to Naples to survey the area of the *B: 12-31-23*
airport. BOSCH decided to use Naples as the departure
point for his planned air raid, and a specific plan was
laid out as to where the plane should be parked for loading
with bombs by BOSCH and his confederates after MM 639-S,
the pilot, parked the plane and went into town. *RES: 201 N.W.*
35th WDE. MIAMI

On April 21, 1966, MM 639-S advised that at
9:30 A.M., that date, he met with BOSCH who decided that
the raid against Nuevitas, Cuba, should be made on the
night of April 21. BOSCH then drove MM 639-S to the
Bacardi Building, Biscayne Boulevard, Miami, where
BOSCH picked up GUAJIRO. They then drove to the Boulevard
National Bank where GUAJIRO wrote out a check for BOSCH
in the amount of \$500.00. This check was cashed by BOSCH
and the \$500.00 was handed by BOSCH to MM 639-S for the
rental of a plane. It was decided by BOSCH, after discussion
with MM 639-S, that the plane was to be flown to Miami
International Airport on the afternoon or early evening of
April 21, 1966; that a co-pilot, to be chosen by BOSCH,
would meet MM 639-S at Miami International Airport and
would fly with him to Naples where they would park the
plane as planned. BOSCH stated that, upon signal from
MM 639-S, the bombs would be transported from Miami to
Naples. BOSCH said that he and his companions would
be waiting for a telephonic message from MM 639-S at
telephone FRanklin 3-1859. It was agreed that the plane
would depart some time during the evening of 4-21-66, for
Naples and that the bombing raid would be made shortly
after midnight. (X) (U)

Customs who had already been briefed on previous developments. Mr. SHANLEY and Mr. SCHACHTER had already worked out a plan of action in agreement with this office and the Collier County Sheriff's Office with the thought in mind of giving maximum protection to MM 639-S. (X)(u)

At 9:40 P.M., 4-21-66, MM 639-S advised that he was ready to depart Miami International Airport and had just notified BOSCH, who said he would immediately bring the co-pilot to the airport. MM 639-S had rented at Florida Airmotive Sales, Inc., Fort Lauderdale International Airport, a twin-engine Cessna 310-I, Registration 8137M, with wing tip tanks. (X)(u)

Before his departure, MM 639-S was alerted by this office of the fact that he would be interrogated by a Collier County deputy at the airport as a possible suspect but that he would not be arrested. (X)(u)

At 1:30 A.M., Mr. SHANLEY telephonically notified this office that BOSCH and two companions had just been arrested by the Collier County Sheriff's Office in possession of six bombs 15 miles east of Naples.

Subsequently Mr. SHANLEY and Mr. SCHACHTER furnished the following details which are of interest to the Bureau.

In cooperation with Customs, Sheriff HENDRY set up a road block 15 miles east of Naples. This road block was manned by two deputies and one Customs agent dressed as a deputy sheriff. From a concealed point Customs observed the two cars, bearing the Cubans, as it approached the road block from a point 5 miles east. When the two cars came to the road block, the deputies simulated a search for two escaped convicts from a Collier County prison camp. One deputy, dressed as a convict and wearing handcuffs, was brought from the adjoining field to an official car along with a bloodhound to simulate the capture of one of the two convicts. The sheriff, within hearing of BOSCH and his companions, made appropriate radio calls and instructed a (X)(u)

deputy to proceed to the Naples airport as a precautionary measure in the event the other convict had made his way there. (u)

At the appropriate time, after MM 639-S and his Cuban co-pilot returned to the airport at Naples, they were approached by a Collier County deputy who questioned them concerning an escaped convict. MM 639-S advised that this was done in a most realistic fashion. The Cuban co-pilot, who was not arrested, has been identified by the Collier County Sheriff's Office as JUAN FRANCISCO FANTONY, 828 S. W. 2nd Street, Miami, born 6-16-43. (u)

7/12 After waiting impatiently for an appropriate period of time, MM 639-S and his co-pilot mutually concluded that something had gone awry since the plane had not been loaded with bombs and BOSCH was not in sight. They then returned to Miami where they encountered MARCELINO GARCIA, the number two man in BOSCH's organization. GARCIA explained that BOSCH had just been picked up while enroute to Naples and that he was going to Naples to assist BOSCH. (u)

7/12 Cuban MM 639-S has expressed the opinion that so far he does not appear to be under any suspicion for his part in this matter. (u)

U. S. Customs has decided not to appear as having been involved in any way in the apprehension of BOSCH and his companions in order to afford further protection to MM 639-S. (u)
