These Cubans offered to sell BOSCH between \$1,500.00 and \$2,000.00 worth of explosives. BOSCH planned to return to Orlando on 6/10/66 to recontact these two Cubans. U. S. Customs plans to follow this matter and try to make a seizure under State of Florida laws dealing with explosives.

SHANLEY said BOSCH and GERVELIO GUTIERREZ CONCEPCION were recently seen testing a 22' blue Seabird fiberglass motorboat in the Miami River. The boat did not have any registration numbers on it and Customs is attempting to identify the boat.

At U.S. Customs' request, the above information re the explosives and the boat is not being disseminated at this time.

On 6/9/66, [Col. FRANKLYN BITHOS, USAFAD] Mami that the Army has no operational interest in MIRR.

On 6/9/66, CIA, Miami, advised that agency has no operational interest in MIRR or any of its members.
