WILLIAM SAMPOL, WHO HAS FURNISHED RELIABLE INFORMATION IN THE PAST, CLASSIFY SECRET, ADVISED SIX SIX, INSTANT, THAT HE WAS IN CONTACT WITH BOTH IGNACIO NOVO, SECRETARY GENERAL OF THE MOVIMIENTO NACIONALISTA CUBANA (CUBAN NATIONALIST MOVEMENT) (CNM), AND GUILLERMO NOVO ON INSTANT DATE AND NEITHER OF THE NOVOS INDICATED ANY CURRENT ACTIVITY OR URGENT PLANS BEING FORMULATED BY THE CNM AT THE PRESENT TIME. (S)(U)

SAMPOL ADVISED THAT WITH REGARD TO PLANS OF DOCTOR ORLANDO BOSCH OF MOVIMIENTO INSURRECCIONAL DE RECUPERACION REVOLUCIONARIA (MIR) MENTIONED IN NY TELETYPE SIX FIVE, LAST, GUILLERMO NOVO STATED ON SIX SIX, INSTANT, THAT NOTHING WOULD BE DONE UNTIL ANOTHER MEETING WOULD BE HELD AT AN UNSPECIFIED DATE WITH EITHER BOSCH OR HIS REPRESENTATIVE. NOVO INFORMED SAMPOL THAT WHATEVER PROPOSALS WERE MADE BY BOSCH AND HIS GROUP RELATIVE TO CARRYING OUT PROPOSED TERRORIST

ACTIONS AGAINST THE CUBAN GOVERNMENT IN CANADA IN CONNECTION WITH CNM PLANS, THESE PROPOSALS OF BOSCH WOULD HAVE TO BE APPROVED BY CNM OFFICIALS IN MIAMI PRIOR TO ANY JOINT VENTURE IN CANADA BY THE CNM AND THE MIRR. (X)(U)

SAMPOL STATED THAT HE ANTICIPATED ASSISTING IGNACIO NOVO IN SETTING UP THE NEW STORE BEING OPERATED BY THE NOVO BROTHERS IN JERSEY CITY. SAMPOL SAID THAT HE WOULD GO TO JERSEY CITY EITHER ON THE NIGHT OF SIX SIX, INSTANT, OR THE NIGHT OF SIX SEVEN, NEXT, AT WHICH TIME HE HOPES TO DEVELOPE ADDITIONAL INFORMATION CONCERNING ANY PLANS, ACTIONS OF THE CNM AND THE NOVO BROTHERS. SAMPOL HAS BEEN INSTRUCTED TO MAINTAIN CLOSE CONTACT WITH THE CNM AND TO IMMEDIATELY NOTIFY THE NEW YORK OFFICE OF ANY DEVELOPMENTS. (X)(U)

THE BUREAU AND INTERESTED OFFICES WILL BE KEPT ADVISED OF ANY FURTHER INFORMATION OR DEVELOPMENTS ON AN EXPEDITIOUS BASIS.
