AT THE MEETING WERE FUTURE PLANS OF ANTI DASH CASTRO CUBANS AGAINST THE PRESENT CUBAN GOVERNMENT AND THESE PLANS CENTERED IN CANADA. ~~(X)(U)~~

THE CONFIDENTIAL SOURCE ADVISED THAT DR. BOSCH WANTED TO CARRY OUT A TWO PRONGED ATTACK AGAINST THE CUBAN GOVERNMENT IN CANADA AND SPECIFICALLY SPOKE ABOUT THE ASSASSINATION OF THE CUBAN AMBASSADOR TO CANADA AND THE ATTACK ON A CUBAN SHIP IN THE PORT OF MONTREAL. BOSCH STATED THAT THEY WOULD NOT USE ANY MEMBER OF THE CNM BECAUSE THEY WERE QUOTE TOO HOT UNQUOTE. BOSCH STATED THAT HIS MAN PAREN FIRST NAME UNKNOWN PAREN GUTIERREZ IN MIAMI HAD NINE ROCKETS, TIMING DEVICES, C DASH THREE AND C DASH FOUR WHICH COULD BE USED IN THEIR FUTURE PLANS. The Cuban Nationalist Movement is a militant anti-Castro Cuban organization which has endeavored to blow up the Cuban pavilion at EXPO 67. According to our New York informant, at least three unsuccessful attempts have been made to place an explosive at the Cuban pavilion and a recent harmless explosion in the water near the pavilion is now being claimed as the handiwork of the group.

The attached indicates that the group is now joining forces with another militant group headed by Orlando Bosch and which has also attempted to set off explosive devices in or near Cuban establishments.

In view of the threats to assassinate the Cuban ambassador, the attached was disseminated by teletype to the White House, State, Central Intelligence Agency, the military agencies and Secret Service. It was also given by cablegram to Legat, Ottawa for dissemination to Canadian authorities. It will also be given to the Department, Customs, Immigration and U.S. Information Agency.

Miami has been instructed to make every effort to fully identify the person in the Miami area who allegedly has explosive devices for use by this group.
