SAs mentioned in the enclosure are ROBERT N. WALL and W. WADE HOMESLEY. Indices check re Movimiento Insurreccional de Recuperacion de la Patria and VALERIO JUAN CAPOTE is contained in reairtel. Indices at WFO are negative re information identifiable with MARTIN CAPOTE and JOSE CRESPO.

Inspector BEYE, U.S. Park Police, noted that only the Park Police afforded coverage to the picketing of The White House, consequently the Metropolitan Police Department was not recontacted regarding this matter.

PINEIRO, mentioned in the LHM, was interviewed by SAs CHARLES E. LENNON and JOHN G. GOEDEL.

SEVERAL OTHER MIRR AND CNM MEMBERS ATTENDED.

ALTHOUGH THE PURPOSE OF THE MEETING OR WHAT WAS DISCUSSED WAS UNKNOWN TO SOURCE BOSCH TOLD SOURCE HE NEEDED PLASTIC EXPLOSIVES, M - ONE TIME FIRING DEVICES (LA-PIZEROS) AND FIFTYSEVEN MILLIMETER RECOILLESS RIFLE SHELLS.

ON JUNE NINE SIXTYSEVEN BOSCH SAID HE HAD AN IMPORTANT MEETING SCHEDULED THAT NIGHT AT THE HOME OF JOSE ANTONIO MULET GONZALEZ, LONG TIME MIRR ACTIVIST AND TREASURER OF MIRR. BOSCH DID NOT STATE THE PURPOSE OF THE MEETING OR WHO WOULD ATTEND. HE REQUESTED SOURCE TO CALL HIM AT EIGHT THIRTY PM ON JUNE NINE SIXTYSEVEN.

SOURCE CONTACTED BOSCH AT EIGHT THIRTY PM JUNE NINE SIXTYSEVEN WHEN BOSCH AGAIN REQUESTED SOURCE TO TRY TO LOCATE EXPLOSIVES AND ARMS PREVIOUSLY MENTIONED. BOSCH ADVISED HE WOULD RECONTACT SOURCE ON JUNE TEN SIXTYSEVEN TO FIND OUT WHAT SUCCESS SOURCE HAD IN LOCATING THIS EQUIPMENT.

PESTONIT WAS REFERRED TO MR. HENRY TAYLOR, STATE DEPT. COORDINATOR OF CUBAN AFFAIRS, MIAMI.
IMMIGRATION AND NATURALIZATION SERVICE
INS, MIAMI, ADVISED RIVERO MADE SAME PROPOSAL TO INS AND WANTED TO CONTACT CIA. INS REFUSED TO ACT AS INTERMEDIARY. US CUSTOMS, MIAMI, ADVISED THEY WERE NOT INTERESTED IN ANY DEAL WITH RIVERO.

MIAMI WILL MAINTAIN CONTACT WITH MM SIX THREE FIVE DASH S AND KEEP BUREAU ADVISED.

INFORMATIVE NOTE

Date 6/10/67

CUBNAT is code name for Cuban Nationalist Movement (CNM) anti-Castro organization headed by Felipe Rivero Diaz. CNM was engaged in efforts to bomb the Cuban pavilion at EXPO 67 on 5/30/67. CNM detonated explosive near the Cuban pavilion.

Immigration has revoked Rivero's refugee status and he has been incarcerated since 5/12/67.

CNM has recently aligned itself with the Movimiento Insurreccional de Recuperacion Revolucionaria (MIRR) another anti-Castro organization headed by Orlando Bosch Avila.

Attached data was disseminated by teletype to the Department of State, CIA, military agencies and Secret Service. It was also furnished to Legat, Ottawa, for RCMP. It will also be furnished to Customs, INS, FAA, USIA and the Department. ~~DECLASSIFIED BY 5668 odd/GAT~~

We are closely following all aspects of this matter.
