WILLIAM SAMPOL, CONFIDENTIAL SOURCE, CLASSIFY SECRET,

ADVISED JUNE TWENTY SEVEN INSTANT THAT ON NIGHT OF JUNE TWENTY SIX LAST THERE WAS DELIVERED BY AN UNKNOWN INDIVIDUAL TO IGNACIO NOVO, A SMALL PACKAGE WHICH UPON EXAMINATION CONTAINED TWO SMALL GREEN BOXES. SAMPOL STATED THAT HE WAS INSTRUCTED TO GIVE THESE BOXES TO GULLERMO NOVO WHEN GULLERMO NOVO CAME TO THE QUALITY SHOE STORE, SEVEN SEVEN THREE BERGEN AVENUE, JERSEY CITY, NEW JERSEY. SAMPOL STATED THAT HE HAD AN OPPORTUNITY OF EXAMINING THE CONTENTS AND DESCRIBED THEM AS FOLLOWS; ONE BOX CONTAINED FOUR INDIVIDUALLY WRAPPED BLASTING CAPS, EACH OF WHICH HAD ONE GOLD COLORED AND ONE RED COLORED WIRE; THE SECOND BOX CONTAINED THREE INDIVIDUALLY WRAPPED BARS OF A PLASTIC EXPLOSIVE.

THIS MATERIAL, ACCORDING TO NOVO, HAD BEEN SENT TO THEM BY DR. ORLANDO BOSCH, HEAD OF THE ANTI-CASTRO ORGANIZATION CALLED MOVIMIENTO INSURRECCIONAL DE RECUPERACION REVOLUCIONARIA (MIRR). SAMPOL STATED THAT ON THE NIGHT OF JUNE TWENTYSIX LAST, GUILLERMO NOVO PLACED ONE OF THE BOXES IN THE EXTREME LEFT HAND DRAWER AND THE OTHER BOX IN THE EXTREME RIGHT HAND DRAWER OF A COUNTER IMMEDIATELY BEHIND THE FRONT DOOR OF THE SHOE STORE. SAMPOL SAID THAT TO HIS KNOWLEDGE, THE MATERIAL IS STILL IN THE SHOE STORE AND IF IT IS MOVED, IT WILL BE TAKEN BY GUILLERMO NOVO MOST PROBABLY TO HIS HOME AT ONE FOUR ONE FOUR NINETY FIRST STREET, NORTH BERGEN, NEW JERSEY. IT IS THE RECOMMENDATION OF THE NEW YORK OFFICE FOR THE SAKE OF THE SECURITY OF THE INFORMANT AND HIS FUTURE USEFULNESS IN THIS INVESTIGATION NOT TO FURNISH THE ABOVE INFORMATION TO LOCAL AUTHORITIES IN JERSEY CITY, NEW JERSEY. IF THE BUREAU FEELS THAT THE ABOVE INFORMATION MUST BE GIVEN TO LOCAL JERSEY CITY AUTHORITIES, [IT IS RECOMMENDED THAT ANY SEARCH OF THE PREMISES BY JERSEY CITY AUTHORITIES BE CONDUCTED WITH A SEARCH WARRANT AND AT SUCH TIME AS BOTH IGNACIO AND GUILLERMO NOVO ARE TOGETHER IN THE SHOE STORE.] (X)(u)

SAMPOL STATED ON JUNE TWENTY SEVEN INSTANT THAT GUILLERMO NOVO WOULD NOT BE AT THE SHOE STORE ON THIS DATE AS THE STORE IS CLOSED AT SIX PM AND THE EARLIEST THAT BOTH IGNACIO AND GUILLERMO NOVO WOULD BE TOGETHER IN THE SHOE STORE WOULD BE AFTER SIX PM ON JUNE TWENTY NINE NEXT. (u)

THE ABOVE MATTER HAS BEEN TELEPHONICALLY FURNISHED TO THE NEWARK OFFICE. BOTH NEWARK AND NEW YORK WILL AWAIT DECISION AS TO COURSE OF ACTION BUREAU DESIRES IN THIS MATTER.

The attached teletype concerns activities of Cuban Nationalist Movement (CNM), militant anti-Castro group bent on bombing Cuban Pavilion at EXPO 67, Montreal, Canada. Ignacio Novo, CNM official, and his brother, Guillermo have been extremely active in these plans. (X)(U)

Attached indicates CNM has received four blasting caps and three boxes of plastic explosives from Orlando Bosch who heads another militant anti-Castro group in Miami, Florida. These explosives are now located in shoe store in Jersey City, New Jersey (X)(U)

Since we are conducting investigation in this matter at specific request of Internal Security of Department, we are checking with that Division to determine whether it has any objection to the data being furnished Jersey City police authorities. If Department has no objection we will instruct our Newark Office to furnish the data to the Jersey City police for appropriate action stressing sensitivity of our source and necessity of protecting FBI as the source of this information.
