and headquarters for the purpose of establishing unity and saving money on office rent. MM T-2 explained that these four anti-Castro organizations have enjoyed a limited degree of cooperation but it was highly doubtful that they would ever establish a unity group or a merger.

On May 12, 1967, MM T-2 stated that Marcelino Garcia claimed that Bosch at that time had two small boats available and was trying to obtain more. However, Garcia said that it was actually more important for the organization to obtain money in order to rent an airplane. However, Garcia did not indicate that the MIRR would have any military operations in the near future.

MM T-3, who is knowledgeable about Cuban revolutionary matters, on June 5, 1967, advised that a meeting took place on the night of June 3, 1967, at a shoe store owned and operated by IGNACIO NOVO, secretary general of the Cuban Nationalist Movement and his brother, Guillermo Novo, a member of the Cuban Nationalist Movement at Jersey City, New Jersey. Present at this meeting in addition to the Novo brothers were Orlando Bosch Avila and Manuel A. de Varona, head of Rescate Revolucionaria Democratica (RRD), an anti-Castro organization with headquarters in the New York area. (X)(U)

MM T-3 said that discussed at this meeting were future plans of anti-Castro organizations against the present Cuban government and those plans were centered in Canada. Bosch wanted to carry out a two-pronged attack against the Cuban government in Canada and specifically spoke about the assassination of the Cuban ambassador to Canada and the attack on the Cuban ship in the port of Montreal, Canada. Bosch stated that they would not use any members of the Cuban Nationalist Movement because they were "too hot." Bosch said that his man (First Name Unknown) Gutierrez in Miami, had nine rockets, timing devices, C-3 and C-4 which could be used in their future plans. Bosch stated that the Cuban exiles wanted to show the U. S. Government, the FBI and (X)(U)

the Immigration and Naturalization Service, that action which had been taken against Felipe Rivero Diaz, head of the Cuban Nationalist Movement, could not stop Cuban exiles in their fight against Fidel Castro of Cuba. (S)(U)

MM T-3 said that Bosch told the Novo brothers and Varona that upon his return to Miami, he would have (First Name Unknown) Gutierrez, send the necessary equipment to one of Bosch's men in the New York area and coordinate future plans with the Cuban Nationalist Movement through the Novo brothers. (S)(U)

MM T-4, a Cuban exile who is in frequent contact with Orlando Bosch Avila, advised that Jorge Gutierrez Ulla, for the past two years, has been acting as press chief in Miami for the MIRR. He works in the office at MIRR headquarters, is about 22 years old, is considered very militant and hostile to the U. S. Government.

MM T-4 on May 16, 1967, advised that on that night there was a meeting in front of MIRR headquarters in Miami which started at about 8 o'clock. The meeting was a joint gathering of Cuban Nationalist Movement and MIRR members for the purpose of getting Cuban exiles to obtain signatures to petitions seeking the release of Felipe Rivero Diaz from jail. MM T-4 said that CNM and MIRR members decided to hold a subsequent demonstration at Bayfront Park in Miami and it was announced that Rivero would start a hunger strike on May 16, 1967.

About 60 to 80 people attended this meeting and the Miami Police Department had uniformed officers outside the MIRR headquarters trying to maintain order.

On June 9, 1967, MM T-4 advised that Bosch said he was going to attend an important meeting that night at 8 p.m. at the home of Jose Antonio Mulet, 201 N. W. 35th Avenue, Miami, Florida, telephone number HI 6-7118. Bosch
