Reairtel contains paragraph, page four, setting out reason PH 614-C-TE believes TONY (LNU), referred to in airtel, is from Trenton. Last sentence of paragraph is not clear as to meaning of informant's statement. Does the informant mean that CHARLES COSTELLO told informant that he (COSTELLO) was once in Trenton and TONY told him the names of the streets that he was driving on or that TONY was once in Trenton?

It is noted that COSTELLO lives in Trenton and the other interpretation of informant's statement would mean TONY was once in Trenton and not a resident of the area.

At present identity of TONY (LNJ), with brother-in-law JIMMY (LNJ), who is involved in the laundry business unknown to Newark.

LEADPHILADELPHIA, AT PHILADELPHIA, PA.

Will determine from PH 614-C-TE true meaning of his statement as set out above and if he has any other information that would link TONY (LNU) with Trenton.
