DAILY SUMMARY.

JEAN BRUNO'S WEDDING ARRANGEMENTS CONTINUE TO DOMINATE ANGELO'S ACTIVITIES. ON FRIDAY, JULY 27, 1962 BRUNO, HIS WIFE, MICHAEL GRASSO, JR., AND ANGELO RUSSO HAD APPOINTMENT, BELIEVED BY ASSOCIATION TO RELATE TO DEAL FOR LAND AT 3RD STREET-OREGON AVENUE, PHILADELPHIA. BRUNO TOLD ABE SEROT, BUSINESSMAN WITH WHOM HE IS FRIENDLY, SETTLEMENT SCHEDULED AUGUST 6 NEXT. ADDED HE HAS ONLY TWO PROBLEMS. FIRST IS GETTING DAUGHTER MARRIED. SECOND IS GETTING NEPHEW (MICHAEL GRASSO, JR.) "OFF HIS BACK AND OUT OF HIS HAIR," AND AFTER SETTLEMENT (AUGUST 6) BRUNO AND WIFE WILL TAKE LONG TRIP ABROAD. THIS IS FIRST MENTION OF SUCH A POSSIBILITY.

BRUNO ASKED GEORGE KATZ, ON JULY 27, MANAGER HEAVY WEIGHT CHALLENGER SONNY LISTON, TO SEE WILLIE (WEISBERG) AND CAPPY (HOFFMAN) FOR HIM. KATZ SAID HE IS FRIENDLY WITH BOTH BUT THEY MAY BE "PEEVED BECAUSE OF YOU AND ME," POSSIBLY INDICATING DISPLEASURE BECAUSE KATZ HAD BRUNO INTERCEDE FOR HIM CONCERNING LISTON. BELIEVED BRUNO WANTED KATZ TO DELIVER WEDDING INVITATIONS PERSONALLY. PH 614-C-TE ADVISED WEISBERG, HOFFMAN, KATZ ALL LISTED AS RECIPIENTS.
