ARRANGEMENTS FOR WEDDING RECEPTION CHANGED. WILL BE IN MAIN BALLROOM BEN FRANKLIN HOTEL, PHILADELPHIA, INSTEAD OF 500 CLUB, ATLANTIC CITY. BRUNO DELEGATED PH 614-C-TE TO SECURE PHOTOGRAPHER FOR RECEPTION. SOURCE WILL DO SO. PHOTOS WILL BE AVAILABLE TO PHILADELPHIA DIVISION.

NEW PARTY, BELIEVED HERMAN BLUM, ENTERED DEAL FOR LAND AT THIRD AND OREGON, PHILADELPHIA, RE WHICH BRUNO HAS BEEN NEGOTIATING WITH AMERICAN STORES COMPANY. SOURCE BEING STUDIED TO DETERMINE BLUM'S POSITION AND PURPOSE. BRUNO CONSIDERED DANGEROUS. COPY MAILED NEWARK.
