Re Newark airtel to Bureau dated 7/26/62.

Referenced Newark airtel expresses Newark's inability to understand the meaning of a sentence described by NEWARK as being on page 4 of Philadelphia airtel to Bureau dated 7/13/62. It is believed that Newark is questioning the last sentence of paragraph 3 on page 5.

For the information of Newark, PH 614-C-TE is not "absolutely certain" that TONY (LNU) is from Trenton, N.J.; however, he "believed" TONY LNU is from the Trenton area as stated in Philadelphia airtel dated 7/13/62.

Informant stated that his belief is based on two observations:

(1) TONY's obvious friendship with CHARLES COSTELLO, a resident of Trenton, N.J.

(2) COSTELLO's statement to informant that TONY had seen him (COSTELLO) driving in Trenton and that TONY had told him (COSTELLO) the names of streets on which he (COSTELLO) was driving when observed by TONY.

Informant was again contacted 7/27/62 concerning the above and was unable to furnish additional information. PH 623-C\* has to date been unable to furnish additional information concerning TONY's identity.
