Determination has been made by the Laboratory that transistorized microphone equipment similar to that contained in the MATE can be built into the type 404B telephone jack. Two such units, one being in color and one ivory in color are being specially constructed for your possible use in connection with authorized installation in case entitled, "Angelo Bruno, AR," Bureau file 92-2717. These units will be shipped to you within five days.

This microphone surveillance device will be known as the 404B MATE. It will be operated from a Regulated Fower Supply in the same manner as other MATE equipment assigned to your office. The yellow terminal of the 404B MATE is positive and the black terminal is negative.

NOTE:

The Electronics Section of the Laboratory is presently developing a procedure for incorporating a small microphone and transistorized amplifier within the type 404B telephone company jack. This jack is part of the plug and jack system used by the telephone company to permit customers to move a telephone instrument from one location to another or to disconnect it from the telephone line. Miami requested in relet that jacks of this type be altered on expedite basis if possible to facilitate effecting of MISUR coverage authorized at residence of Charles I. Costello, North Miami, Florida. Two jacks are being specially constructed from available parts to meet this need.
