RE MY TEL AUGUST 21, 1962 AND PHILADELPHIA TEL CALL NEWARK THIS DATE.

PH 614-C-TE ADVISED AUGUST 21, 1962, ANGELO BRUNO RECEIVED TELEPHONE CALL FROM MADELINE COSTELLO, WIFE CHARLES COSTELLO, FROM MIAMI, FLA. MADELINE REPORTEDLY TOLD BRUND SHE WAS IN MIAMI AND FLYING TO PHILADELPHIA FROM MIAMI APPROXIMATELY 1 PM, AUGUST 21, ARRIVING PHILADELPHIA LATE EVENING AUGUST 21, AND WOULD BE ACCOMPANIED BY 4 CHILDREN.

SUBSEQUENTLY BRUNO CONTACTED CHARLES COSTELLO AND COSTELLO APPARENTLY TOLD BRUND HIS WIFE WAS CONFUSED ABOUT FLYING TIMES, THAT SHE WOULD ARRIVE PHILADELPHIA APPROXIMATELY 7 PM, AUGUST 21, AND HE, CHARLES, WOULD PICK HER AND CHILDREN UP AT AIRPORT AND STOP BY BRUNO'S HOME FOR SHORT VISIT.

INFORMANT INDICATED BRUNO ASKED MADELINE IF SHE HAD PICKED UP "THE MAIL FROM CHUCK," WHO APPARENTLY SAID SHE HAD NOT. DURING CALL WITH COSTELLO, BRUNO TOLD CHARLES HIS WIFE DID NOT PICK UP MAIL BUT IT DID NOT MATTER BECAUSE HE, BRUNO, WAS GOING TO VISIT MIAMI.
