DAILY SUMMARY, PH 623-C* ADVISED AUGUST 18 INSTANT, BRUNO'S SISTER, JOSEPHINE GRASSO, HAS BEEN REQUESTED BY INS TO COMPLETE FORMS RE HER CITIZENSHIP. UNKNOWN LAWYER ADVISED BRUNO, HIS SISTER SHOULD NOT COOPERATE WITH INS UNLESS THEY SUBPOENA HER. LAWYER TOLD BRUNO GOVERNMENT IS TRYING TO PRESSURE SISTER INTO BEING GOVERNMENT INFORMANT. ON SAME DATE BRUNO MET WITH CAPOREGIME, PHILIP TESTA AND FORMER REPRESENTANDO ANTONIO POLLINA DURING WHICH MEET COMMISSION DISCUSSED. TAPE SENT NEW YORK FOR TRANSLATION.

CALOGERO SINATRA, ACCORDING TO ABOVE SOURCE, WENT TO TRENTON, N. J., FRIDAY NIGHT AND TO NEW YORK ON AUGUST 20, INSTANT AND WOULD RETURN TO PHILA IN TWO OR THREE DAYS.

PH 614-C-TE ADVISED AUGUST 20, INSTANT, FELIX JOHN DE TULLIO, NEWARK HOODLUM, MADE APPROXIMATELY EIGHT PHONE CALLS DURING DAY IN EFFORT TO CONTACT BRUNO. SUBSEQUENTLY MEET SET UP FOR MIDNIGHT BETWEEN DE TULLIO, BRUNO AND JAMES SCAFIDI, ASSOCIATE OF DE TULLIO, AT THE FRIENDLY BAR, EIGHTH AND WASHINGTON STREET, PHILA. PURPOSE

PH 623-C* AND PH 614-C-TE ADVISED ON AUGUST 20, INSTANT, BRUNO MET WITH RUSSELL BUFALINO, PHILA TOP HOODLUM, DURING DAY. PURPOSE MEET UNKNOWN.

FOR INFO MIAMI AND NEWARK NEITHER OF ABOVE INFORMANTS KNOW OF ANY PROPOSED TRIP BY BRUNO OR CHARLES COSTELLO TO MIAMI, DURING THIS WEEK. TRIP BY BRUNO TO MIAMI WOULD BE HIGHLY UNLIKELY DUE TO BRUNO'S INVOLVEMENT IN HIS DAUGHTER'S MARRIAGE, AUGUST 26 INSTANT.

PH 614-C-TE BELIEVES BRUNO MAY TRAVEL TO ATLANTIC CITY, N. J., ON WEDNESDAY OR THURSDAY, THIS WEEK, IN EFFORT TO OBTAIN SERVICES OF SINGERS DEAN MARTIN AND OR FRANK SINATRA FOR DAUGHTER'S RECEPTION ON SUNDAY, IN PHILA. INFORMANT ADVISED MARTIN IS CURRENTLY WORKING AT 500 CLUB AND WILL BE JOINED BY SINATRA DURING WEEK, DATE UNKNOWN. PH 623-C* HAS CONFIRMED BRUNO'S INTEREST IN MARTIN AND SINATRA FOR ABOVE PURPOSE.

PHYSICAL AND TECHNICAL COVERAGE OF BRUNO WILL BE AFFORDED CONTINUOUSLY ON AUGUST 23 INSTANT.

MIAMI REQUESTED TO IMMEDIATELY ADVISE PHILADELPHIA UPON COMPLETION OF THEIR INTEREST.
