SINATRA's personal airplane landed at the AC Airport at 1:55 a.m., 3/25/62. Departing from the plane were six people. SAMMY DAVIS, JR. and what appeared to be his manager (a white male) departed from the airport with an AC police officer in an unmarked police car for the 500 Club. SINATRA's plane described as a Martin 202.

Three men and a woman departed from the airplane and left the airport in a car bearing New Jersey License GWL-239, which is a rental car from the Hertz Rent-A-Car Company in AC. The people in the rented automobile were believed to be pilots and employees of SINATRA.

Former NK 2153-C advised on 3/24/62 that on the night of 3/23/62 BRUNO and two unsubs plus FRED TEZZI; "PAPPY" TPPOLITO; JOE MARINO, aka. "FINGERS"; LOUIS BILOTTI, and several other unknown persons were at the 500 Club, AC.

Newark sources at the Claridge Hotel, AC, advised that telephone calls were being received for a JOSEPH BONANNO, but that representatives of the SINATRA group refused to receive the messages on 3/23/62. However, on 3/24/62 messages were received by the SINATRA group and presumably delivered to JOE BONANNO.

SAs of the Newark Office observed a person believed to be JOE BONANNO and three unsubs leaving the Claridge Hotel at 9:41 a.m., 3/25/62. These individuals departed in a 1961 Oldsmobile with New Jersey License CBA-697 registered to ANN IANIERI, 107 South Mississippi Ave., AC. ANN IANIERI is the wife of VINCENT IANIERI, who was a former hotel manager in AC. It is noted that VINCENT IANIERI was a principal arrested in a gambling raid in AC in August, 1958.

MAURIO FLORIANO, AC PD Captain, advised in strictest confidence on 3/24/62 that as of 4:30 a.m., 3/24/62, he had seen SAM GIANCANA, BUDDY GRECO and his wife, and KEELY SMITH in the private dining room on SINATRA's floor. GIANCANA reportedly had made a reservation on 3/24/62 for an unknown number of people at the 500 Club under the name of SAM MOONEY.
