PH 614-C-TE REPORTED BRUNO CONTINUES TO CONDUCT BUSINESS AT FRANK IANNARELLA'S LUNCHEONETTE, 742 CHRISTIAN STREET, PHILA. BRUNO AUTHORIZES LOANS. IANNARELLA GIVES MONEY TO BORROWER AND COLLECTS PAYMENTS.

PH 623-C* STATED BRUNO TOLD NICHOLAS PICCOLO, LOCAL NUMBERS OPERATOR AND MEMBER PHILA FAMILY LA CAUSA NOSTRA, THAT UNNAMED MAN, MIAMI, FLA., STARTED EXTERMINATING BUSINESS IN MIAMI 6 WEEKS AGO OBTAINING LESS THAN \$60 WORTH OF BUSINESS IN FIRST MONTH OF OPERATION. MAN AT FIRST RESISTED, THEN CAPITULATED AND AGREED TO PARTNERSHIP WITH BRUNO DAY BEFORE BRUNO LEFT MIAMI FOR PHILA SEPTEMBER 26-27, 1962. BRUNO IN ONE DAY OBTAINED \$400 WORTH OF EXTERMINATING BUSINESS FOR UNMAN FROM DAVEY GLASS, BENNY GAINES, THE SANDS, SCHEME POLE (PHONETIC), AND PADDY'S (GINNITTI - PHONETIC). BRUNO ENLISTED ASSISTANCE OF JOE MANGONE, HARRY ZIMAND, AND FREDDIE (LNU) WHO ARE SOLICITING STOPS FOR UNMAN IN BRUNO'S ABSENCE. AIRMAIL COPY MIAMI.
