ANGELO BRUNO, AKA.; AR. DAILY. PH 614-C-TE AND PH 623-C* EACH REPORTED ON MEETING MAX WILLY WEISBERG AND ANGELO BRUNO PENN JERSEY VENDING, OCTOBER 11 LAST. PH 623-C* FURNISHED DETAILS WHEN BRUNO OUTLINED RESULTS OF BRUNO'S MEETING, DATE UNKNOWN, WITH ONE OF THREE PARTNERS: BILL HOPKINS, CUTTER COHEN, AND FNU BEECH, WHO OWN DIRECT FACTORY BEER FRANCHISE FOR PABST, LOWENBRAU, RHEINGOLD AND NATIONAL BEERS FOR ENTIRE STATE OF NEW JERSEY AND 50 PERCENT OF FRANCHISE IN FOUR PENNSYLVANIA COUNTIES: DELAWARE, BUCKS, MONTGOMERY, AND PHILADELPHIA. PERSON DESCRIBED AS JIMMY MOORE PRESENTLY OWNS 50 PERCENT OF FRANCHISE PHILADELPHIA COUNTIES. PERSON BRUNO TALKED WITH DESCRIBED BY HIM AS JEWISH LAWYER MILLIONAIRE. BEECH ALSO A MILLIONAIRE. HOPKINS DESCRIBED AS TRENTON, N. J., RESIDENT AND A "KNOCK AROUND." BRUNO DECLINED PROPOSAL OF DISTRIBUTORSHIP STATING HE DESIRED ONE THIRD TO ONE HALF OWNERSHIP OF PENNSYLVANIA FRANCHISE FOR HIM AND HIS TWO PARTNERS: MAX WILLY WEISBERG AND JOHNNY (FELIX JOHN DE TULLIO). WEISBERG CONCURRED AND AGREEABLE TO ADDITIONAL NEGOTIATIONS WITH FRANCHISE OWNERS AT LATER DATE TO BE SET BY BRUNO. WEISBERG CAUTIONED BRUNO IF BREWERIES LEARNED OF POLICE RECORDS OF BRUNO AND HIS PARTNERS, FRANCHISE DEAL WOULD FALL THROUGH. BRUNO ASSURED HIM BRUNO WAS FRANK WITH FRANCHISE OWNER, DESCRIBING BRUNO AND PARTNERS AS KNOWN TO POLICE AS HOODLUMS WITH POLICE
