PH 623-C* INDICATES INTERNAL STRUCTURE OF LA CAUSA NOSTRA
IN UNITED STATES IS SAME AS IN SICILY. SOURCE ADVISED
LA CAUSA NOSTRA IN SICILY IS GOVERNED BY "COMMISSION"
AND IS MADE UP OF PERSONS BEARING TITLES, REPRESENTATIVES,
COUNSELORS, UNDERBOSSSES, CARPREGIMES AND SOLDERS. SOURCE
ALSO ADVISED THERE APPEARS TO BE AN INTERNATIONAL BODY
ACTING AS LIAISON BETWEEN VARIOUS COMMISSIONS.

DETAILS OF CONVERSATION BETWEEN BRUNO, PHILIP TESTA
AND ANTONIO POLLINA BEING SENT BY AIRTEL. TESTA IS
CAPOREGIME UNDER BRUNO. POLLINA WAS INTERIM BOSS OF
PHILA FAMILY BETWEEN JOE IDA AND BRUNO.

FURTHER REVIEW OF FILM OF BRUNO'S DAUGHTER'S
