NOTE: Angelo Bruno of Philadelphia is one of the top echelon hoodlums in the nation wide criminal organization composed of individuals of Italian background. Information has been received in the past that he may be a member of the nine man "commission" which is the top ruling body of the organization. PH 623-C\* is a misur covering Bruno's office and furnishes extremely valuable information. Philadelphia Office advised that Bruno's 1962 Chevrolet Impala was involved in minor accident while parked and office source will have possession of the car for repair on approximately November 27 or 28, next. Bruno uses this car during contacts of hoodlum associates in evening hours and during trips to New Jersey and surrounding areas.
