In response to your teletype request dated 11-19-62, Bureau Laboratory Supervisors James T. Freeman, William E. Harvard and Winton P. Walter travelled to the Philadelphia Office on 11-26-62, made preparations for, and installed on the night of 11-27-62, a Concealed Automobile Transmitter (CAT) in an automobile involved in above-captioned case. The CAT equipment was tested at the conclusion of the installation and same operated satisfactorily.

The following technically trained personnel of the Philadelphia Office (in addition to other personnel of that office) were present at the CAT installation: SA J. Robert Pearce, SA James J. Finley and Electronic Maintenance Technician James P. Creed. These men received limited technical training in the installation, use, and removal of CAT equipment and are, therefore, considered qualified to replace or remove the CAT equipment now in use in this specific case and to handle the tape recording in a Bureau automobile of information received from the CAT.

Should the CAT equipment, at a later date, be in need of repair or other service, your office should contact the Bureau, attention Laboratory, regarding any special information or equipment needed.
